

# Unaccompanied Minor Hire Form

The Perisher Blue Ski Hire supplies Snow Sports equipment hire to Murrays and Levers customers purchasing 1 (one) day ski packages. The following information is required to assist Perisher Blue staff process the Snow Sports equipment requirements for an unaccompanied minor, that is, a person under 18 years of age not accompanied by a parent or legal guardian on the date of a Murrays or Levers introductory ski package tour to Perisher Blue Ski Resort.

It is a requirement at Perisher Blue that a Hire Form be prepared and signed by the parent or legal guardian of a minor. Where the parent or legal guardian of the minor will not be present at the Perisher Blue Ski and Snowboard Hire at the time the equipment is issued to the minor, the information required by the Hire Form must be completed in advance by completing this "Unaccompanied Minor – Hire Form".

The information requested on this form will replace the Hire Form that is used at Perisher Blue on arrival at Bullocks Flat.

### IMPORTANT, Please note:

1. The height, weight, age and skier ability details of the unaccompanied minor are required to assist us with ski binding adjustments. We ask that you complete this information very carefully to ensure the correct binding settings are calculated for the unaccompanied minor;
2. It is necessary for the parent / legal guardian of the unaccompanied minor to read, understand and voluntarily sign and date the Conditions of Hire that apply to the equipment hired;
3. Credit Card details are also required as a security deposit for the equipment hired.

Please read and carefully complete this 2-page form and ensure that the unaccompanied minor presents this form to Ski and Snowboard Hire Staff upon arrival at Perisher Blue.

**CONDITIONS OF HIRE**

1. All goods are hired and used at the Hirer's own risk on behalf of the unaccompanied minor and no condition, warranty or representation of safety, suitability or fitness is expressed or implied by Perisher Blue Pty Limited, or by its employees or agents.
2. The signing of these conditions will constitute an acknowledgment by the Hirer on behalf of the unaccompanied minor that the goods hired will be supplied and adjusted according to the height, weight, age and skier ability details provided on this Form for the unaccompanied minor and that the goods hired will be in good repair and are free from defect at the time of hiring.
3. The Hirer on behalf of the unaccompanied minor understands and acknowledges that Alpine Activities (including skiing and snowboarding) are risky and dangerous and may result in personal injury to participants.
4. The Hirer on behalf of the unaccompanied minor understands that the snowboard/snowblade equipment being hired forms part of, or all of, a snowboard/snowblade / boot/ binding system which is a NON RELEASE system and that its use cannot guarantee the users safety, nor does it reduce the risk of injury to the user.
5. The Hirer on behalf of the unaccompanied minor understands that the ski / boot / binding system will not release at all times or under all circumstances where release may prevent injury, nor is it possible to prevent injury, nor is it possible to predict every situation in which it will release, and it is, therefore, no guarantee of the users safety.
6. NO refund or part thereof will be given for early return of goods.
7. This agreement is personal to the Hirer on behalf of the unaccompanied minor and shall not be assigned to any other person and no equipment hired may be lent, sub-hired, transferred or otherwise dealt with in any matter whatsoever.
8. Subject to any non-excludable statutory provisions, Perisher Blue Pty Limited shall not be liable for any injury, loss, delay, inconvenience or damage of any kind whether due to accident, breakdown, defect, negligence, or from any other cause whatsoever, and to the fullest extent permitted by law all conditions, warranties and representations to the contrary are excluded. Any liability of Perisher Blue Pty Limited which by statute may not be negated shall be limited to the resupply of the goods or the payment of the cost of the resupply of the goods.
9. The Hirer on behalf of the unaccompanied minor will be responsible for damage or loss howsoever caused to the goods and equipment and may be charged the full replacement value.
10. The Hirer on behalf of the unaccompanied minor will indemnify and keep indemnified Perisher Blue Pty Limited, its servants, agents and assigns from and against all claims, losses, expenses and damages howsoever arising from the hire or use of the goods, including, but without limiting the generality of the foregoing, all damage or injury to any person or property whatsoever.
11. The Hirer on behalf of the unaccompanied minor will return all hire goods and equipment on the last day of the hiring period and will be responsible for their good order and condition. If the hiring period is exceeded daily hire rates will be charged.
12. The Hirer has read and understood and agrees to the above condition on behalf of the unaccompanied minor. The Hirer declares that s/he is over 18 years of age and is a parent or legal guardian of the unaccompanied minor.
